

Assumption of the Risk Acknowledgment, Waiver of Liability, and Agreement Relating to Coronavirus/COVID-19

The novel coronavirus/COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and believed to spread mainly airborne from person-to-person and personal contact. As a result of the contagious nature of the virus and its potentially dangerous symptoms, federal, state, and local governments, as well as federal and state health agencies have recommend social distancing and face mask usage and, in many locations, have limited and/or prohibited and/or regulated the congregation of groups of people.

All American Youth Football and Drill Team league (“AAYFDT”) has adopted the Center for Disease Control’s (“CDC”) recommended preventative measures and are making them mandatory in order to reduce the spread of COVID-19. Through AAYFDT’s governance of the league teams, namely the Klein Texans and Angels (“the Team”), have implemented these same measures; however, the Team cannot guarantee you or your child(ren) will not become infected with COVID-19. Further, even with these mandatory measures in place and adhered to, attending the Team’s events, including, but not limited to practices, games, and performances could increase your risk and your child(ren)’s risk of contracting COVID-19.

“By signing this waiver of liability, assumption of risk acknowledgment, and agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the Team’s events and that such exposure or infection may result in personal injury, illness, permanent disability, and/or death. I agree to abide by AAYFDT’s mandatory preventative

measures required of all participants, their families, and all event attendees. I understand these mandatory safety measures may be amended throughout the season as new developments arise and the CDC's recommendations evolve. I attest that I am and my child(ren) are not currently exhibiting COVID-19 symptoms, have not tested positive for COVID-19, or knowingly been in direct contact with anyone who has tested positive for COVID-19; and that if I, he or she comes down with symptoms, I, he or she will seek immediate treatment and notify the Team's president.

I understand that the risk of becoming exposed to or infected by COVID-19 at the Team's events may result from the actions, omissions, or negligence of myself and/or others, including, but not limited to, the Team's volunteers, board members, coaches, team moms, AAYFDT game officials, fellow program participants and their families, and events attendees. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and/or death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Team's events or participation in the Team's programming (all together defined as "Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Team, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs, and/or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Team, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any the Team's events."
